**Check with ALL members of your Bridal Party before signing this contract. We require payment in full for the amount of people you have indicated above requiring services. The person who signs will be held legally responsible for payment whether or not all services are performed. We ONLY book On-Site wedding parties with 3 or more people due to our schedule and time away from the salon.

Thank you for inquiring about our bridal makeup and hair services. Please read over our policies below.

Deposit Policy: We receive many inquiries a year in advance and dates do fill up quickly. Therefore, we require a 150.00 (non-refundable) deposit along with this signed service contract to reserve stylist(s) for your event and it will be deducted from the total cost due at the time of services. Your deposit will be sent back to you in the event a booking comes in before your deposit arrives. Your date is not reserved until your check has been cashed. (Please make checks payable to The Shear Edge Salon) or you can pay with cash or credit card.

Booking Policy:

You may add more people receiving services. Please contact Gore Salon to make sure we have time to accommodate more people. We allot time per wedding party according to the amount of people you indicated above receiving services. This means we sometimes turn away other wedding bookings if we do not have time to accommodate them. **Check with ALL members of your Bridal Party before signing this contract. We require payment in full for the amount of people you have indicated above requiring services.** The person who signs will be held legally responsible for payment whether or not all services are performed. We ONLY book On-Site wedding parties with 3 or more people due to our schedule and time away from the salon.

Cancellation Policy:

You may cancel your services up to 45 days prior to the wedding date. After 45 days your deposit will not be refunded. Also, your deposit will not be refunded in the event of sickness, accident, Act of God or other reasons beyond control. If we the stylist(s), are subject to being unavailable, every effort will be made to assist you in making other arrangements and your deposit will be refunded.

Travel Fee:

Travel fee will be determined prior to booking by distance and location. Columbia, Lexington and Irmo areas, are \$50.00 per stylist attending. All parking fees, if required to travel to your hotel room, must be paid with cash or validation. An \$80.00 fee will be charged if arrival time is before or after business hours.

Holiday Fee:

\$200.00 will be added to weddings booked on a holiday or a holiday weekend. (Major Holidays)

Assistant Fee:

2 stylists are included for your event of 5 or less people. Assistants are booked when you have a large wedding party of 5 or more, OR if you have a limited time to get ready. If a large Bridal Party is receiving Hair and Make-Up, additional assistants will be added automatically! \$150.00 per additional assistant will be charged. Gore Salon will let you know the total number of stylist and assistants needed for your event before signing this contract.

Payment:

The bride will be responsible for paying the total amount due to the salon. If each individual (s) is providing their own payment, the individual (s) will need to pay the bride or person signing the contract and the responsible party will make one lump sum payment to Gore Salon.

By signing this contract, I understand that the deposit is non-refundable. I also acknowledge I am responsible for payment of the total number of people receiving makeup and hair services as I indicated above. I have read and understand the policies outlined above. Extra fees if applicable will be added to final bill. I will abide by this contract. Cash or check only, please.
